In this Cookie Statement, you can find information about the way Vipio B.V. ("Vipio", "we", "us" or "our") uses cookies on www.vipio.com ("the Website"). This Cookie Statement applies to you when you visit the Website.

What are cookies?

Cookies are small, simple text files that a webpage server places and stores on the hard drive or memory of your computer, tablet or any other electronic device you use to visit vipio.com ("Device"). By placing a cookie, the webpage server can recognise your Device and send the stored information back to the webpage server.

Third-party cookies record the date and time of your first and current visit. They also collect your IP address and/or other unique device number. Our own cookies do not record this. A cookie cannot damage your Device or the files stored on your Device.

The period of validity of cookies from the moment they are placed on your Device may vary. A number of cookies used by Vipio are session cookies. This means that they are automatically deleted from your hard drive when you end your session (i.e. when you log out or exit our platform). The permanent cookies remain until they are deleted or their validity period expires. Our permanent cookies have varying durations, ranging from 90 days to several years. We never store these permanent cookies longer than for the purposes described below. You can also delete permanent cookies yourself via the browser settings. An explanation of how to do this is provided in this Cookie Statement.

How do we use cookies?

The various cookies are explained below. We use both our own cookies and third-party cookies placed on your Device.

Vipio's cookies

Necessary cookies

We use necessary cookies to display the Website and enable navigation. These cookies also allow us to remember your preferences and settings, for example, to accept or reject certain cookies and to remember your user name so that you can log in quickly before placing a bid. Our cookies are necessary for the Website to function, adding functionality for you and/or improving your experience.

Third-party cookies

Google Analytics

Vipio also uses Google Analytics cookies. Thanks to Google Analytics, we know, for example, what accommodation packages are being searched for, how long a page takes to load and how people navigate through the Website. This information enables us to compile anonymous reports so that we can improve our Website and make it easier to find information.

Tracking cookies

The advertising networks we work with place tracking cookies on your Device. These tracking cookies collect information about your browsing activities on the

different websites you have visited. We use this information to tailor the content of the advertisements shown to you and limit the frequency of these advertisements. We may also place tracking cookies that are used to build a profile of your browsing activities.

Refusing or deleting cookies

When you first visit our Website, we ask your permission to place cookies that are not necessary or functional and that impact your privacy. If you do not give permission, these cookies will not be placed. In this case, you may not be able to use all of our Website's functionalities.

If you no longer wish to allow cookies, you can change your internet browser settings to block their placement. You can find more information on this below or, if your internet browser is not listed, in the Help function of your internet browser.
